RULES AND REGULATIONS

The debate is open to the students of classes IX to XII.

- ◆ Each school can select **any one** topic for the Preliminary Round.
- ✤ The competition will be held online using the platform- 'Microsoft Teams'.
- Each school should send entries for one team comprising of two members- One speaker 'for the motion' and one speaker 'against the motion'.
- ♦ Once the registration is closed, Microsoft ids will be provided to the students and further instructions regarding the conduct of the debate will be shared. The school will be informed about the date of the Preliminary Round for their school i.e., 20 or 21 August 2021.
- Only the teams qualifying the Preliminary Round will participate in the Final Round to be held on <u>3 September 2021</u>. Qualifying teams will be informed about the topic for the Final Round well in advance.
- ♦ All participants must have a device with good broadband/ Wi-Fi connection. Uninterrupted network connection must be ensured from the participants' end, the school will not be responsible in case of poor connectivity or network failure.
- The participants will participate in the competition from their respective homes. They must deliver their speech in sitting position with a plain, light backdrop.
- On the day of the competition, the participating teams must join the scheduled 'Microsoft Teams' meeting latest by 8:30 am.
- ✤ It is mandatory for the participants to wear plain white uniform for the competition. The identity of the participating school should not be revealed at any time.
- Time allotted to each speaker is 3 minutes. A warning buzzer will be sounded after 2.5 minutes. The final buzzer will ring to indicate the end of stipulated time. Negative marking will be done for exceeding the time limit.

RULES AND REGULATIONS

- Use of script or taking help from online sources at the time of speaking will result in disqualification.
- ◆ Each speaker will be interjected (one question) by the judges.
- The speaker's reply should not exceed one minute. Cross questioning is strictly not allowed.
- ✤ The speakers will be assessed on the basis of content, delivery, diction, confidence and rebuttal.
- The decision of the judges will be final and binding.
- ✤ Participation certificate will be awarded to all the participants.
- The winning team will be awarded a 'Rolling Trophy'. The school is entitled to keep the trophy for a year and is responsible for its maintenance and safe custody.
- ◆ Best Speakers and Runners Up will be felicitated with trophies and merit certificates.
- ✤ The host school will participate but will not compete for the Rolling Trophy.
- Kindly submit the entries online using the link : <u>https://bit.ly/ldeologue2021</u> (Google Form) latest by 09 August 2021.
- ✤ Names once registered will not be changed.
- The winners' trophies as well as the 'Rolling Trophy' will be safely delivered to the winning schools. The e-certificates of participation and merit will be emailed to the respective schools.
