Order

I am directed to convey the approval of learned Director of Education vide U.O. No. 9501/DE dated 17/12/2021 vide which following have been approved.

- (A) School would become Co-educational school from a single sex institution from 2022-23 onward from the entry level only.
- (B) Change of Nomenclature of the school from existing St. Mark's Girls Sr. Sec. School (School ID. 1617210) to "St. Mark's World School" with same ID i.e. 1617210.

The said approval has been granted subject to the following conditions:


- (i) That the society concerned will continue to abide by the conditions of grant of recognition and various provisions of DSEAR, 1973 and rules made there under.
- (ii) That no unauthorized or recognized classes shall be run or the premises shall not be used for any other purpose than those permitted by the said Act & Rules.
- (iii) That by the change of name of the said school, there will be no change in the Managing Committee of the school.
- (iv) That the notification of change in the name of the school will be published in at least two leading news papers of Delhi within a week of date on which approval of Director of Education for change of name is received.
- (v) That it is only the change of name from St. Mark's Girls Sr. Sec. School to "St. Mark's World School" with same and character of the school will remain unchanged/ unaltered.
- (vi) That the change of name shall also be intimated to the office of Registrar of the Societies, Govt. of NCT of Delhi.
- (vii) That the Director of Education shall not be responsible for any dispute out of change of name of the school.
- (viii) That the change of name from "St. Mark's Girls Sr. Sec. School" to St. Mark's World School" is under the same society i.e. St. Mark's Christian Educational Society, Registration No. S/8009 of 1976, B-32, first floor, Community Centre, Janak Puri, New Delhi- 110058 and the liabilities of the School before name change will be the liabilities of the School after name change.
